



TUITION AND FEES - 2018/2019 (ALL INCLUSIVE)

*Please note that all prices are quoted in RMB.

Tuition fees include application and registration fees, full year tuition, school transportation, textbooks, campusbased school activities, day trips and all "supportive" education (Art, Music, Foreign Language and Physical Education). The optional afternoon sports and activities programs (SK – Grade 12) are also offered at no additional charge.

Enrollment Deposit

An enrolment deposit of RMB 20,000 is payable upon the offer of a place in school. A seat will not be guaranteed until these fees are paid. It will be credited against the new school year's tuition fees.

Re-enrollment Deposit

A re-enrollment Deposit RMB 20,000 is payable by April 30 each year to guarantee a place for the following school year. This deposit will be credited against the next school year's tuition fee.

School Uniform

All students are required to wear the school uniform to school. All uniforms items are available for purchase.

Optional Fees

- Travel expenses related to ACAMIS events, Explore China trips, Duke of Edinburgh Award excursions, NAE China region events and NAE Summer Camps
- Swim School
- A laptop is expected for grade 7-12 and the Ti-Nspire graphing calculator is expected for grade 9-12.

Payment Dates

Annual Tuition Fees must be paid in full before 1 August, 2018. Pupils may only attend school if fees have been paid.

<u>Semester Tuition Fees</u> are paid per semester in advance. 1.5% interest on the second semester's tuition is payable with the semester one payment. For this option, semester fees are due no later than:

Semester One: 1 August 2018 Semester Two: 15 December 2018















Late Enrollment

If a pupil is enrolled into the school after 1 October, the tuition fee will be charged by prorated school days, but with a minimum of 10% of the annual fee. In this case, the semester tuition fee payment option will not be available. No refund will be available for early withdrawal of students who enrolled after 1 October.

Important Notices

- Payment can be credited to our bank account via electronic/bank transfer. However, cash payments can only be made using Chinese currency (RMB). If you choose to use an electronic/bank transfer, a copy of the bank remittance, together with the child's name and grade should be forwarded to our office. Conversion from USD to RMB will be based on the selling exchange rate of the first working day of the month the invoice was issued, as published by the Bank of China.
- Parents wanting to pay by USD should consult with the finance office and get a US dollar tuition invoice before making the bank transaction.
- 30 days (excluding holiday) notice of withdrawal in writing must be given or 30 school days' fees will be payable in lieu of notice. Parents must ensure that written acknowledgement is received from the school following notice of withdrawal.

Refund Conditions for the 2018-19 School Year

- Before 30 April 2018 Full refund
- Before 1 July 2018 Full refund less the deposit of 20,000RMB
- Between 1 July and 14 August 2018 Full refund less 25,000RMB
- Leaving in the middle of the academic year 30 days (excluding holiday) notice of withdrawal in writing must **be given to admissions office.** The tuition fee will be charged as below.
