2. Payment of Fees

Tuition fees are calculated on an annual basis, but are payable annually or termly in advance by the first day of each school term.

Where the school fees remain unpaid after the due date, the school may impose a 2% late payment penalty per month to the outstanding balance. In the event of non-payment of tuition fees, the school has the right to refuse to accept the student into the school.

Application Fee

A non-refundable and non-prorated application fee of IDR 4,240,000 is payable upon submission of an application form to the school.

Development Fee

This non-refundable and non-prorated fee applies to every child enrolled for 2022-2023 academic year.

Sibling Discount

A sibling discount of 10% may be offered where three or more children from the same family attend school. The percentage discount is applicable only to the youngest sibling's tuition fees. (Families enrolled at NAS Jakarta prior to 2019-20 will be eligible to continue with the 2018-2019 sibling scheme for the duration of their enrolment at NAS Jakarta).

Refund

Prior to the start of Term 1

In the event a family decides to withdraw from NAS Jakarta after payment of the Annual or Term 1 Tuition Fee, 60% of the paid tuition fee will be refunded.

Prior to the start of Term 2 or Term 3 (Tuition Fee paid termly – Plan 2)

If a family decides to withdraw from NAS Jakarta after payment of the upcoming term's Tuition Fee, 60% of the paid tuition fee will be refunded.

During the school year (Annual Tuition Fee - Plan 1)

In the event a family decides to withdraw from NAS Jakarta after payment of the full Annual Tuition Fee, the school will refund a pro-rate maximum 40% of the Annual Tuition Fee based on the last day of school (conditional of 30 days' notice requirement).

During the school year (Tuition Fee paid Termly - Plan 2)

Where students withdraw from NAS Jakarta mid-term or at the end of a school term, and where Tuition Fees have been paid according to the Instalment Scheme, there will be no refund.
